RE: Case #CPC-2021-9909-DB-SP-SPP-HCA AND ENV-2021-9910-EAF 7577 West Foothill Blvd. Tujunga, CA 91042 **NON-SUPPORT OF PROJECT**: Proposed 46-unit, 42-foot tall Multi-Family Apartment building located in the Foothill

Blvd Corridor Specific Plan C2-1, CR-1VL & RD2-1 zones.

Summary: The Sunland-Tujunga Neighborhood Council (STNC) Land Use Committee (LUC) met with the owner's representative, Edgar Khalatian, at our January 10, 2022 public meeting. Mr. Khalatian gave a power point presentation.

The Sunland Tujunga Neighborhood Council strongly opposes this proposed project for the following reasons:

- Request for a Specific Plan Amendment & Special Plan Project Permit Compliance: The project violates the commercial-only provisions of the Foothill Boulevard Corridor Specific Plan (FBCSP), does not meet the needs of the community, requests numerous changes and entitlements to enable building the project and would negatively impact the quality of life and the safety of the neighboring community. It should be noted that the project is prohibited under the commercial-only provisions of the FBCSP. The developer is requesting an amendment to the FBCSP to create a new target area to allow for residential construction. This would create an undesirable precedent.
- Community concerns: Sunland-Tujunga needs commercial development to provide new jobs, small business opportunities, and entertainment venues such as restaurants for the community. The community is concerned that this developer has not made any arrangements for developing appropriate improvements to the infrastructure, such as water, sewage, electricity, adequate emergency fire evacuation routes, traffic and adjacent traffic / parking congestion. The small-town nature of this community and the mountain views are all valuable aspects of Sunland-Tujunga and protected by zoning overlays. The size and density of this project will tower over the three street intersections of Plainview Avenue, Foothill Boulevard and Day Street and will block the mountain and Valley views for surrounding properties which the community insists is the unique quality and basis of their property value. The increased density, without adequate study and without infrastructure improvements will diminish the enjoyment of the neighboring properties and decrease property values for the current residents and property owners.
- Traffic, Parking and Safety Concerns: The streets around the project are narrow. No accommodation for guest parking has been made except to say the guest can park on Wilsey which already is over- crowded with very limited city street parking; and yet the developers have not included improvements to ameliorate this problem. Further, Plainview, Foothill and Day Street converge into one intersection directly in front of the project, creating confusion and hazards for both drivers and pedestrians. The traffic problems existing at this three-street intersection have not been addressed by the developers and will increase with the additional vehicles from this development.
- Ingress and Egress: The developers show just one ingress and one egress to the parking structure at Plainview. It is unclear in the plans how the developer will mitigate the existing and soon- to-be created traffic problems.
- Evacuation Concerns: Foothill Boulevard is the only commercial corridor in this community and serves as the only evacuation route for all of the residents of Sunland-Tujunga, both on the East and West sides of the town. In the event of another wild fire, or other natural disasters requiring immediate evacuation, the congestion of residents at this intersection would increase the bottleneck danger already existing.

Aesthetics: Overall, this gigantic building looming over the intersection would be out of character with the community. It would decrease rather then increase the quality of life for the area, both in terms of reduced aesthetics and by not providing the commercial products and services that our Sunland-Tujunga residents do need.

The STNC recommends that the request to amend the FBCSP be denied. The community remembers that this property has a long and successful history of restaurant use and recognizes its highest and best use is for a restaurant, specifically family-style. The economic feasibility of a restaurant has been established. It is zoned for restaurant use including the two zoning overlays, so it is legally feasible. The past one-story restaurants with onsite parking, ingress and egress from both Foothill Blvd and Plainview, shows a commercial restaurant is physically possible . Further, the community insists that if alternate uses outside of the zoning overlays are considered, that (1) an EIR be required to address the concerns noted above (2) all impacts of such an egregious development on the community be studied, (3) mitigating actions including wild fire evacuation, water use, utilities infrastructure and traffic be addressed and (4) that these issues be resolved before project approval.

Upon the recommendation of the STNC's Land Use Committee, the Sunland-Tujunga Neighborhood Council, at its February 9, 2022 meeting voted to oppose this application by a vote of \_\_\_\_\_(yea), \_\_\_\_\_ (nay), \_\_\_\_\_(abstained) and \_\_\_\_\_ (recused)

#### SUNLAND-TUJUNGA NEIGHBORHOOD COUNCIL

The Sunland-Tujunga Neighborhood Council is in favor of CF 22-0002-S5 – to support AB 1603 (Salas) / Property Value / Grand Theft Threshold Decrease / Proposition 47 City of Los Angeles hereby includes in its 2021-2022 State Legislative Program SUPPORT for AB 1603 (Salas) which would decrease the threshold for value of property in thefts that can be charged as grand theft from \$950 to \$400. The newly introduced bill would amend Prop 47 by lowering the threshold for shoplifting from \$950 to \$400.

People who commit crimes should be accountable for their crimes. By lowering this threshold the number of smash and grab crimes would be lessened and offenders would be subject to the more stringent penalties imposed for grand theft crimes. Our police and justice system would benefit from being able to appropriately address these crimes. The overall result would be the lowering of crime and increased safety in all of our neighborhoods.

#### (Neighborhood Council Elections / Fiscal Year 2020-21 / COVID-19 Pandemic)

The Sunland-Tujunga Neighborhood Council has a number of serious concerns regarding the spending patterns and failures of oversight by the Department of Neighborhood Empowerment on the 2021 neighborhood council election and their impact on candidate recruitment and voter engagement. The neighborhood councils function as the closest level of government for four million Angelenos. However, leadership failures by the Department of Neighborhood Empowerment permeated this election cycle. Given that the Department of Neighborhood Empowerment is requesting <u>one million dollars</u> for the upcoming election cycle, we felt it necessary to express our grave concerns regarding their stewardship of the money in the previous election cycle after a careful and thorough examination of public documents.

#### We are thankful to the Reseda Neighborhood Council for their diligence in researching this data.

The Sunland-Tujunga Neighborhood Council requests a full accounting of the money spent and the money remaining from the \$456,000 allocated to the Department for the 2021 election. We request a full accounting of how and why vendors were selected; many of whom did not have a track record of election experience or high levels of social media engagement. We request that contractual obligations that were not independently verifiable by this neighborhood council be reviewed for their fulfillment and the outcome be shared with all neighborhood councils and the City Council. Payments of \$5,000 were each made to four vendors. For two of these vendors, their digital engagement posts occurred after the conclusion of the election. For the remaining two, their engagement was so insignificant, the Reseda Neighborhood Council struggles to understand the justification for their \$5,000 payments.

Our first concern comes from the \$5,000 awarded to the <u>Dangerman Education Foundation</u> for "2021 election outreach." It is notable that this payment is specifically for services rendered after all the neighborhood council elections had concluded from July 1, 2021 to September 5, 2021 as listed in the detailed view on the <u>Controller's website</u>. The final neighborhood council election was on June 15, 2021. Every <u>twitter post</u> by self-styled superhero Dangerman occurred after the elections had already been finalized. Each <u>instagram post</u> also followed this pattern. The <u>youtube video</u> with 34 views followed this pattern. We question why someone who's social media feed lacks regular organic engagement and whose primary audience appears to be school children (who are too young to participate in neighborhood council elections) would be selected as an election outreach advocate. Additionally, we are also curious why none of the ads contained the <u>federally required</u> disclosure of payment for sponsored posts. Lastly, given that graphics were professionally produced to promote engagement in neighborhood councils, we question why a photo of a rumpled flyer (Exhibit A) was deemed to be acceptable paid content and who at the Department of Neighborhood Empowerment was responsible for both approval of this content and this contract.

Similarly, the Los Angeles County African American Employees Association (LACAAEA) was paid \$5,000 presumably to promote Neighborhood Council elections, but the <u>sole post</u> on July 19, 2021 on their twitter and facebook accounts occurred after all elections had closed. This

check is earmarked on the city controller's site as being specifically for the 2021 election digital media campaign. How can a digital media campaign consist of one twitter post and facebook post only after the conclusion of the elections? Why was outreach to an underrepresented minority group only done after the conclusion of the elections?

Additionally, the All People's Community Center received a payment of \$5,000 for "general assistance". All People's Community Center did not promote the elections on their instagram. All People's Community Center had 2 facebook posts total on May 6th and May 10th asking voters in region 9 (CANNDU, Central Alameda, Empowerment Congress Southeast, Empowerment Congress Southwest, South Central, Voices, Watts, Zapata King) to request their ballot. There were no follow up posts to remind voters to submit their ballot by election day. The posts had a total of 9 likes. Votes were down 77% in region 9 from the 2019 election. More voters left their ballot unreturned (389) than actually voted (255) in this region with 60% of ballot requesters not returning ballots.

Koreatown Youth and Community Center Inc also received a \$5,000 payment for "in person and virtual outreach". Their digital engagement included only four facebook and <u>instagram</u> posts which did not include a direct link to request a ballot. Their <u>twitter</u> account was not used to promote the elections. Engagement was low on all posts with few likes and was lower than their average engagement. We would like to know the scope of the agreement between all of the above organizations (Dangerman, LACAAEA, All People's, and KYCC) and the Department of Neighborhood Empowerment as contracts are not publicly available for amounts of \$5,000 and under. The Reseda Neighborhood Council questions the lack of dynamic and timely digital media engagement by these organizations.

We next review a series of much larger payments and their accompanying public contracts. The Reseda Neighborhood Council uncovered a pattern of unfulfilled contracts, erroneous information, and, shockingly, payment for a council election not even scheduled to occur in 2021.

Our first concern is regarding the \$53,200 contract with Evitarus, a survey and public policy polling firm. Despite this contract being approved on March 15, 2021 by BONC, the contract was not executed until after the elections on June 16, 2021. Evitarus was identified in the 2021 election justification report as a possible vendor for general and microtargeting voter engagement with a total budget of \$165,000 allocated for these purposes. Given that this contract was not signed until after the election and the Department has admitted that this has now become a neighborhood council engagement and awareness survey, that is a significant lapse in voter engagement that affects every neighborhood council. Additionally, Evitarus does not advertise itself as a firm focused on voter engagement, but rather on data analysis and polling. We question why this firm was selected in the first place for possible voter engagement as it does not specialize in it. This contract represents more than 10% of the total allocated budget and is a significant expense. Why was the execution of this contract delayed by months and how were stakeholders disengaged by the shifting of its purpose? Evitarus promised to reach 1.2 million Angelenos to "provide key information to Residents about current and future NC elections, such as candidate filing, ballot request, and voting deadlines and requirements; and provide information to Residents about opportunities and methods for candidates and/or voters to register to participate—including online and other available resources." This did not occur and the contract is likely unfulfilled. Our constituents pay this price. 2/9/22 STNC Board Packet 009

#### The failure to execute the contract with Evitarus in a timely manner to engage candidates and

voters is particularly concerning in the light of the election spending moratorium by Facebook. The moratorium was lifted on March 4, 2021. This means that voter engagement in regions 5, 6, 7, 8, and 1 was significantly affected and candidate recruitment was even more severely impacted and affected every region. The Reseda Neighborhood Council worries that many regions suffered a significant disadvantage for voter turnout that the Department of Neighborhood Empowerment has failed to adequately acknowledge or address how they would fix in the future.

Our next concern is regarding the contract with AltaMed Health Services for \$20,000. Altamed's contract specified that they would do voter engagement targeting 5 neighborhood councils: MacArthur Park, East Hollywood, Westlake North, Boyle Heights, and Watts. The Reseda Neighborhood Council is curious why a contract was executed that specified MacArthur Park for voter engagement given that MacArthur Park did not have an election scheduled for 2021. The contract was executed on April 9, 2021. This means that Neighborhood Council elections for East Hollywood and Westlake North had passed by the time this contract was signed. In addition, Boyle Heights had already passed its deadline for ballot requests. Additionally, the Altamed contract specified that information about neighborhood council elections would be shared on all social media platforms, including facebook, twitter, and instagram with a goal of 30,000 impressions. No posts regarding neighborhood council elections were made to their twitter or instagram account despite this contractual obligation. Additionally posts to their Facebook account referenced neighborhood councils that do not exist. A June 8th posting on Facebook encouraged voters to request a ballot for the Harbor Gateway Neighborhood Council. There is no Harbor Gateway Neighborhood Council. There is Harbor Gateway North and Harbor Gateway South. Another post encouraged voters to vote in the Van Nuys North Hollywood Neighborhood Council. There is no Van Nuys North Hollywood Neighborhood Council. Additionally, posts encouraged readers to vote in the Empowerment Congress Neighborhood Council. There are 5 neighborhood councils with Empowerment Congress in their name spread across 2 neighborhood council regions with differing timelines (Empowerment Congress Central, Empowerment Congress North, Empowerment Congress West, Empowerment Congress Southeast, Empowerment Congress Southwest). Accurate information is so incredibly important when doing "get out the vote" activities. The carelessness of these posts could not possibly have helped voter engagement and turnout.

Finally, we have concerns regarding the \$20,000 contract with Central City Neighborhood Partners to promote four neighborhood councils: Westlake North, Westlake South, Pico Union, and Rampart Village with an allocation of \$5,000 per neighborhood council specified in the contract. This contract was executed on March 22, 2021, which means that the three neighborhood councils under contract in region 6 (Westlake North, Westlake South and Pico Union) had no election outreach support as specified in the contract. Westlake North and South had a total of 10 voters despite having 16 registered candidates between them. With an allocation of \$5,000 per neighborhood council, this means the elections for these two councils represent the most expensive election in US history when evaluated by the cost per vote metric at \$1,000 per vote cast. Each region was supposed to have up to 21 social media postings in March 2021 regarding the election. However, only Rampart Village was promoted on their facebook, twitter, and instagram accounts with two total posts dedicated to the election across platforms. Central City has promoted neighborhood council meetings following the election and the Reseda Neighborhood Council wonders if this may be connected to the noted deficiency in meeting the bare minimums of their contract. It is noted that while awareness of the neighborhood council meetings is welcome, this does not promote participation in elections. Given the deficiencies in the 2/9/22s Settle Ctr Board c Packet da Neighborhood Could 0 must wonder if voters were actually telephoned for this election as specified in the contract with



Lastly, while \$456,000 was requested and allocated for the 2021 election, we do not believe nearly that amount was spent based on receipts filed with the controller's office. There is a minimum of \$150,000 that appears to have been left unspent based on current filings. Payments for outreach to the unhoused and youth that were detailed in the justification budget appear to have not been spent. The Reseda Neighborhood Council would like to inquire why. We would also like to inquire where these funds will be used moving forward. If the Department did not spend their full election budget, then what justifies a doubling of their budget moving forward? Perhaps, Neighborhood Councils should be given access to additional supplemental funding in election years as an alternative to increasing the election budget of the Department of Neighborhood Empowerment in light of these serious findings of mismanagement.

The Reseda Neighborhood Council presents this detailed report because we are gravely worried about the future of neighborhood council elections if steps are not taken to acknowledge and remediate the leadership failures apparent at the Department of Neighborhood Empowerment during this process. We believe the Department of Neighborhood Empowerment presented an inaccurate picture of the full scope of the election in their report of the 2021 election outreach results. We believe that taxpayer money was mismanaged and squandered. We do not bring this to the City Council and the Board of Neighborhood Commissioners lightly. However, the Sunland-Tujunga Neighborhood Council is committed to the improvement of and the empowerment of neighborhood councils throughout the City of Los Angeles and joins with the Reseda Neighborhood Council in our belief that the findings in this report need to be explored further and thoroughly.

Funding to fund and upgrade facilities for the Olympics should be done with other funding sources and not a bond funded by City taxpayers. STNC Bylaws- Censure Process

**Section 8: Censure** – The purpose of the censure process is to place a Board member on notice of misconduct and to provide the Board member with an opportunity to correct the misconduct. The Neighborhood Council may censure any Board member at a regular or special meeting open to the public following a good-faith determination by the Neighborhood Council Board that the member has engaged in conduct that is contrary to rules and regulations applicable to the Board or that impedes the orderly business of Board operations.

Grounds for censure include, but are not limited to, persistent disruptive conduct at meetings, violations or abuses of the Board's bylaws or rules, violations of the Code of Conduct, acting on behalf of the Board without authorization, and misuse or abuse of the censure or removal process by acting in bad faith.

The Board shall use the following procedure when censuring a Board member:

1. A motion to censure a Board member may be initiated by any three (3) Board members. Those Board members shall not constitute a majority of the quorum of any Neighborhood Council body, such as a committee. The motion shall be delivered to any officer of the Board or a specific officer or member of the Board as may be specified in the bylaws or standing rules of the Neighborhood Council. The motion shall be in writing and provide the specific facts and grounds for the proposed censure including the date(s) and specific conduct relied upon for the motion. The motion shall not be based upon conclusions, e.g., "for alleged violations of the Code of Conduct" but shall contain factual statements that describe conduct only and is not intended to embarrass or humiliate the board member.

2. The Board member, group of Board members or committee responsible for setting the final Board agenda shall include the motion on the agenda of the next regular or special Board meeting scheduled at least thirty (30) days following the delivery of the proposed censure motion.

3. The Board member subject to censure shall be given a minimum of thirty (30) days prior-written notice, which may include email sent to the last email address on file with the Neighborhood Council, of any meeting at which the motion to censure will be considered. The notice shall provide the specific facts and grounds for the proposed censure as specified in 1 above. The Board shall also provide a copy of the notice to the Department of Neighborhood Empowerment a minimum of thirty (30) days prior to the meeting at which the motion to censure will be considered.

4. The Board member subject to censure shall be given a reasonable opportunity to be heard at the meeting, either orally or in writing, prior to the Board's vote on a motion of censure.

5. The Board shall decide by a majority vote of those present and voting whether or not the Board member should be censured. The Board member who is the subject of the censure motion shall not be counted as part of the majority present and voting and shall not be allowed to vote. For the purpose of censure motions, abstentions shall not be counted as votes.

6. In no event shall a motion to censure a board member be heard by the Neighborhood Council within sixty (60) days of the next scheduled Board election or selection.

POLICY NUMBER: 2014-2(1)

**WHEREAS**, the Board of Neighborhood Commissioners (Commission) established Working Groups comprised of current and past Neighborhood Council members and Neighborhood Council stakeholders on January 26, 2013, to recommend changes to the Plan for a Citywide System of Neighborhood Councils;

**WHEREAS**, the Commission believes the following Code of Conduct (Attachment A) will address some of the concerns and recommendations of the Working Groups;

**WHEREAS**, the Commissioners recognize that a Neighborhood Council System that is physically and emotionally safe and secure for all Board Members promotes good citizenship, increases Stakeholder attendance and supports community engagement;

WHEREAS, Neighborhood Councils are required under Article II of the Plan for a Citywide System of Neighborhood Councils to be diverse, inclusive and open to all Stakeholders;

WHEREAS, the Commission expects Board Members to conduct themselves in a manner in keeping with an established Code of Conduct and with a proper regard for the rights and welfare of other Board Members, Stakeholders, Committee Members, and volunteers;

**WHEREAS**, the Commission recognizes that improper conduct may occur within the Neighborhood Council System and among members of Neighborhood Councils;

**WHEREAS**, the Commission expects Board Members to reaffirm their commitment to the Code of Conduct every 2 years.

WHEREAS, Section 902 (b) Article IX of the new Charter provides that the Board of Neighborhood Commissioners "shall be responsible for policy setting and policy oversight and the promulgation of rules and regulations but not be responsible for day-to-day management."

**Now, therefore, be it resolved** that the Board of Neighborhood Commissioners amends this policy to inform Neighborhood Council members of that type of conduct which this Commission and others deem harmful to the Neighborhood Council system.

#### POLICY NUMBER: 2014-2(2)

- 1. Neighborhood Council Board Members are required to either, read and sign a copy of the Code of Conduct attached as Exhibit "A" or participate in training approved by the Department of Neighborhood Empowerment (Department).
- 2. As of November 1, 2016, every Neighborhood Council Board Member, who has not signed the Code of Conduct in 2016, whether elected, selected or appointed, shall provide a signed and dated copy of the attached Code of Conduct to the Department bearing their signature or participate in training approved by the Department. Thereafter, every Neighborhood Council Board Member shall be required to re-sign the Code of Conduct or participate in training approved by the Department every two years.
- 3. On or after November 1, 2016, a newly elected, selected, appointed or re-elected Neighborhood Council Board Member shall provide a signed and dated copy of the attached Code of Conduct to the Department bearing their signature, or participate in training approved by the Department within 30 days of the election or selection being certified by the Department or within 30 days of selection or appointment to the board. All new Neighborhood Council Board Members shall renew their Code of Conduct every two years thereafter.
- 4. Any Neighborhood Council Board Member who fails or refuses to review, sign, date and provide a copy of the attached Code of Conduct to the Department or participate in training approved by the Department within the abovementioned time frames shall be suspended from their Neighborhood Council and shall not act on any matter that comes before their Neighborhood Council and shall not be counted for the purpose of establishing a quorum of the Neighborhood Council.
  - a. The Department shall notify the Board Member of their suspension by sending a letter to their last known email address and/or physical mailing address.
  - b. The Department shall also notify the remainder of the Board Members by email and/or U.S. mail of the suspension of the Board Member.
- 5. If within 30 days of being suspended the Neighborhood Council Board Member does not provide a signed and dated copy of the attached Code of Conduct to the Department bearing their signature or participate in training approved by the Department they shall be removed as a Neighborhood Council Board Member by the following procedures:
  - a. The Department will notify the Board Member of their removal by sending a letter to their last known email address and/or mailing address.

- b. The Department will also notify the remainder of the Board Members by email and/or U.S. mail regarding the removal of the Board Member and that the Board Member's position on the board shall be considered vacant.
- c. Any Board Member removed pursuant to this policy shall have the right to present to the Department evidence that he or she has in fact complied with this policy. The Department shall be the sole decision maker as to the sufficiency of the evidence submitted.

Neighborhood Council Board Members should treat other Board Members and members of the public with respect regardless of the other's opinion, ethnicity, race, religion, religious belief or non-belief, color, creed, national origin, ancestry, sex, sexual orientation, gender, gender expression, age, disability, marital status, income, homeowner status, renter status or political affiliation.
- Neighborhood Council Board Members should not, during meetings, functions or events engage in or threaten to engage in any physical attack on any other individual.
- 4. Neighborhood Council Board Members should not use language that is threatening, obscene, or slanderous, including profanities, insults or other disparaging remarks or gestures directed toward other Board Members.
- 5. Neighborhood Council Board Members should promote and, if necessary, enforce a safe meeting environment. If other Board Members become disruptive or violate the Code of Conduct Neighborhood Council Board Members have agreed to abide by, Board Members should demand that the offending Board Member conduct themselves in a respectful and orderly manner.
- 6. Neighborhood Council Board Members should not engage in "bullying" or harassment which is generally defined as follows:
  - a) "Bullying" is conduct that meets all of the following criteria:
    - i. is reasonably perceived as being dehumanizing, intimidating, hostile, threatening, or otherwise likely to evoke fear of physical harm or emotional distress;
    - ii. is directed at one or more Board Members;
    - iii. is conveyed through physical, verbal, or technological means;
    - iv. substantially interferes with participation opportunities, benefits, or programs of one or more Board Members at Neighborhood Council sponsored activities or events;
    - v. adversely affects the ability of a Board Member to participate in or benefit from the Neighborhood Council programs or activities

by placing the Board Member in reasonable fear of physical harm or by causing emotional distress; and,

- vi. is based on a Board Member's actual or perceived protected characteristic (see 2 above), or is based on an association with another person who has or is perceived to have any of these characteristics.
- b) "Harassment" is conduct that meets all of the following criteria:
  - i. is reasonably perceived as being dehumanizing, intimidating, hostile, threatening, or otherwise likely to evoke fear of physical harm or emotional distress;
  - ii. is directed at one or more Board Members;
  - iii. is conveyed through physical, verbal, or technological means;
  - iv. substantially interferes with participation opportunities, benefits, or programs of one or more Board Members at Neighborhood Council sponsored activities or events;
  - adversely affects the ability of a Board Member to participate in or benefit from the Neighborhood Council programs or activities because the conduct, as reasonably perceived by the Board Member, is so severe, pervasive, and objectively offensive as to have this effect; and,
  - vi. is based on a Board Member's actual or perceived protected characteristic (see 2 above), or is based on an association with another person who has or is perceived to have any of these characteristics.

I have read and understand the Neighborhood Council Board Member Code of Conduct. I understand that if I fail to provide the Department of Neighborhood Empowerment with a signed and dated copy of this Neighborhood Council Board Member Code of Conduct I may be subjected to suspension and/or removal from my Neighborhood Council Board.

#### 3. Pledge of Allegiance - Led by Dan Kellgreen

#### 4. Presentation by Local Service Club - The American Legion

Dan Calgreen gave the presentation, describing the mission of the organization. He said they are currently doing a blanket drive for homeless veterans and that it is a non-political entity. He stated that they are involved in youth sports and the Boy Scouts.

Lallah Rowe asked if the American Legion could be opened up to the community and how it was involved in education. Mr. Calgreen stated that the organization was open to the community and that it taught history through its veterans' experience.

#### 5. Comment by Elected Officials/Representatives, Done, City Departments (3 min per Representative) - .

**Eve Sinclair**, Area Director from Councilwoman Monica Rodriguez's office, discussed COVID in the area, stated that a new testing site would be open on November 17, that they were working with local churches to administer vaccines, that there would be a vaccination drive at Stetson Ranch, that the Project Homekey Goodnight Inn site was now open and that several homeless people had accepted housing that the Summer View site would also be open soon, and that Care and Care Plus teams were working to provide homeless services. She stated that no-overnight parking restrictions for oversized vehicles was now being enforced in several areas, that there was an EMROD clean-up recently, that on December 23rd there would be a food give-away, Howard Finn Park would receive new lighting, fencing was repaired at the Veterans' Memorial, that there would be a new slurry seal on Tujunga Blvd, that the Oro Vista Green Corridor Project was moving ahead, that the Tujunga Canyon and Marcus Sewer project was moving forward, and asked for donations for veterans.

Chairwoman Grant asked about the construction at North Valley City Hall and asked if items in storage could be moved to avoid paying storage charges. Ms. Sinclair stated she would look into moving the items.

Cindy Cleghorn asked if a trash receptacle at Commerce Ave and Tujunga Blvd could be picked up. Ms. Sinclair stated that she believed it had been. 2/9/22 STNC Board Packet 042

Mr. Schmidt asked how the contractor would be selected for Oro Vista and stated that he wanted to share a vaccine death report with her. Ms. Sinclair stated that design had not begun yet and that they would do a call-out ahead of work beginning.

Cheryl Schmidt described the RV overnight parking situation and stated that neighbors had been getting death threats from RV occupants. Ms. Sinclair stated that the motion had been waived out of the Transportation Committee and was in process.

**SLO Contreras** stated that there continued to be a slight decrease in crime from last year, that they were currently tracking an armed burglary suspect, and asked those in attendance to call 911 if they spot a suspicious person. He stated that they had been dealing with an RV encampment, but that with the moratorium they could not impound or threaten to impound such vehicles unless crimes were being committed.

Jon von Gunten asked if any of the arms taken from the burglary suspect were rifles with telescopic sights. SLO Contreras stated that only handguns had been captured.

Ed Babakhanian asked about a casino bust and a liquor store robbery. SLO Contreras stated that he had no updates on the robbery and that the casino was illegally operating and was a revolving issue.

**Gilessa Hernandez**, new Field Deputy for Assemblymember Rivas, introduced herself, and gave her email as <u>gilessa.hernandez@asm.ca.gov</u>. She stated that the office would be able to assist with any state issue, including EDD, DMV, and CALTRANS. She stated that they had facilitated a vaccine pop-up site and that more were scheduled for later this month.

**Vanessa Serrano**, spoke about upcoming training opportunities, including the Core Onboarding series, and drafting agendas, CIS's, and funding workshops. She spoke about BONC's upcoming draft of its digital media policy and the meeting at which it would be discussed.

Ms. Cleghorn stated that the date for the BONC meeting was Monday and asked about moving items into storage. Ms. Serrano stated she would see what she could do to help.

Mr. Schmidt asked about the digital media policy changes. Ms. Serrano stated she would send them to the Board. Chairwoman Grant stated that it is on the agenda.

#### 7. Presentation: Tree People

Pat Kramer gave a note on the presentation. She spoke about a tree-watering event that the group had held, stating it was well-received and that they were in contact with Steve List, the urban forestry representative for the area. She stated that he said the trees needed maintenance and that he would work with the council office on it. She stated that the Councilwoman said she would work with Mr. List on tree maintenance.

Xiomara Duran gave the presentation with screen sharing, stating that she had been appointed as a tree ambassador. She stated that the tree canopy had many benefits, including cooler temperatures, and that poorer neighborhoods tended to have fewer trees. She stated that heat-related deaths commonly went unreported and that a fraction of current land use was dedicated to trees. She went over the program's goals, including applying for tree applications. She discussed how to adopt trees and gave her email as <u>xduran@treepeople.org</u>.



Chairwoman Grant asked who to contact. Ms. Kramer stated that they could contact Tree People dire **14** and suggested holding a joint event.

**12.** Discussion/ Action Motion to support or not support the newest version of the Digital Media Policy and submit STNC position to the Board of Neighborhood Commissioners.

Chairwoman Grant presented the policy, stating it covered what Board members could say on digital forums. She read Section 8.3, stating its intent was to drive people towards the Board website. She read the social media policy in Section 8.6 and stated the policy would not allow promoting non-profit organizations on the website. She stated that official City images would not be allowed to be posted on social media and that news articles could not be shared by Board members if it could become a Board issue. She stated that she could send a letter to NC presidents asking them to join the Board in opposition.

Mr. von Gunten stated this would allow Board members to bring issues before the Board solely to cause another Board member to be in violation of the policy if they had posted an article about it.

Ms. Rowe stated that this would mean that Board members could not post articles about the homeless. Mr. Seigel stated that if these policies did not apply to other legislatures and only neighborhood councils it seemed extremely punitive and suggested contacting other neighborhood councils to rally opposition to the policy.

Mr. Schmidt and Ms. Cleghorn suggested voting to oppose the policy tonight.

Mr. von Gunten suggested adding language that would make clear that the policy should not be construed to abridge any Board member's right to freedom of speech if they are not acting in an official capacity.

#### Introduction

Thank you for your interest in serving as a Neighborhood Council board member. You are choosing to join some of the most dedicated community servants in the City of Los Angeles. You will have an opportunity to work with other amazing people who are also dedicated to helping their communities. We appreciate your decision to serve.

There are many aspects to being a Neighborhood Council board member. The Board of Neighborhood Commissioners (Commission) establishes policies and promulgates rules and regulations relating to the Neighborhood Council System. Commission adopted a *Leadership Orientation Policy* [https://empowerla.org/wp-content/uploads/2020/04/NC-Leadership-Orientation-Policy-2 020-01-30.pdf] in early 2020. The policy requires the Department of Neighborhood Empowerment (Empower LA/Department) to ensure that candidates for neighborhood council board service are aware of the roles and responsibilities of board members. EmpowerLA and the Office of the City Clerk are required to certify that candidates have been advised of and understand these responsibilities. The Commission recognizes that Neighborhood Council board members might need to expand their leadership skills. You can learn more about mandatory trainings on the Department's website [https://empowerla.org/nctrainings/].

If elected, you will be provided with access and, in some cases required, to participate in advanced trainings in several areas. Some of the trainings offered include training in communication, coalition building, and conflict resolution. Additional trainings include how to develop positive interpersonal relationships that bring about an atmosphere of equity and inclusiveness. Developing these skills and understanding helps board members manage some of the challenges associated with managing a properly functioning neighborhood council board.

Separately, candidates for board service must affirm that they will educate themselves on and follow all laws, rules, policies, and procedures applicable to the Neighborhood Council System (System). These include policies of the Board of Neighborhood Commissioners, the Department of Neighborhood Empowerment, and the Office of the City Clerk. Each of these offices has a separate role in the System. The information and descriptions below implement the Commission's *Leadership Orientation Policy* and expectations.

**Statement of values.** The Neighborhood Council system tailors LA's municipal government to the City's communities, ensuring that recognition and accommodation of these communities' diversity is built into City governance.

**Role of Neighborhood Councils.** To promote more citizen participation in government and make government more responsive to local needs, a citywide system of Neighborhood Councils. Neighborhood Councils shall include representatives of the many diverse interests in communities and have an advisory role on issues of concern to the neighborhood.

**How Neighborhood Council Tools.** There many ways in which Neighborhood Councils influence City Council policy and advance the interest(s) of their communities. For example, they can advise their City Council representatives and submit community impact statements on behalf of their Council. They can serve on Neighborhood Council committees, or serve on the Board of Neighborhood Commissioners. They can also participate in groups that support dialogue in the System such as the Neighborhood Council alliances.

What it means to be an NC board member. As a Neighborhood Council board member, there are <u>several compliance</u> requirements to consider. Board members are required to complete mandatory training sessions, follow their neighborhood council's bylaws and standing rules, and engage the public in their work in a meaningful, transparent, and inclusive manner. Mandatory training topics include, but are not limited to, the following:

- A. Code of Conduct
- B. Ethics
- C. Funding training
- D. Planning 101 (required for planning committees)
- E. Diversity, equity, inclusion, and anti-bias training (in progress)

The Code of Conduct, Ethics, AND Funding training are required to vote on any financial matters before the board.

**Responsibilities of NC Board members.** Neighborhood Council board members volunteer their time, network and expertise, committing on average 10 – 20 hours a month, on behalf of the Neighborhood Council System and are subject to pertinent laws that govern city departments and government entities. Neighborhood Councils make recommendations to City decision-makers. Neighborhood Councils are neither decision-making nor legislative bodies and are subject to pertinent laws that govern City department entities.

**Role of the Department of Neighborhood Empowerment.** EmpowerLA has a diverse role in supporting the Neighborhood Council system. EmpowerLA's core responsibility is to provide *direct neighborhood council support*. In addition to providing meeting and training support for Neighborhood Councils, EmpowerLA is also expected

to ensure that Neighborhood Councils boards follow all laws, policies, and procedures that apply to the Neighborhood Council System. EmpowerLA's Office of Community Engagement also conducts trainings to City departments, elected offices, and stakeholders about the System. The Department is as a liaison between Neighborhood Councils and these City decision-makers.

**Role of Office of the City Attorney.** The Office of the City Attorney Neighborhood Council Advice Division performs the function of general counsel for the City's Neighborhood Council System and advises on the laws that impact the operations of the Neighborhood Councils including laws that pertain to conflict of interest.

**Role of Office of the City Clerk.** Office of the City Clerk sets regulations, policies, and guidelines regarding the funding of the Neighborhood Council System and administers neighborhood council elections.

- A. Neighborhood Council Election Handbook [hyperlilnk]: The Neighborhood Council Election Division handbook and website provide voters, candidates, and other neighborhood council participants with important policies and information about the neighborhood council election process.
- B. Neighborhood Council Funding Program Policies and Guidelines: The Neighborhood Council Funding Program [https://clerk.lacity.org/neighborhood-council-funding/funding-trainings-and-wo rkshops] issues policies and guidelines related to the funding provided to neighborhood councils.

#### **Regulatory Framework**

As you begin your journey with the Neighborhood Council System, it is essential to know about the regulatory framework within which the System operates. These laws may range from the Brown Act, the Public Records Act, the Americans with Disabilities Act, City Administrative Codes, Commission Policies to the Neighborhood Council bylaws, and standing rules.

#### Federal Laws Governing the Neighborhood Council System

A. U.S. Constitution. Provisions of the U.S. Constitution, including the First Amendment's Free Speech, Establishment, and Free Exercise clauses, may be applicable to Neighborhood Council operations, such as meetings and events.

- B. Americans with Disabilities Act. The Americans with Disabilities Act is a federal law designed to protect the rights of individuals with disabilities. Title II of the Americans with Disabilities Act (ADA) applies to the operations of state and local governments and may be applicable to the operations of neighborhood councils
- **C.** The Political Reform Act of 1974. The Political Reform Act is a state law meant to ensure that certain public officials are free from bias caused by their own financial interest and act in an impartial manner. Neighborhood Councils abide by applicable provisions.

#### State Laws Governing the Neighborhood Council System

- A. The California Public Records Act. The California Public Records Act is a state law providing the public access to public records. Neighborhood councils must respond to Public Records Act (PRA) requests for its records.
- B. California Constitution. The state constitution protects individual rights and may be applicable to Neighborhood Council operations, such as meetings and events. Other relevant provisions include Article XVI, section 6 (the prohibition against a gift of public funds), and Article I, section 3 (incorporation of the California Public Records Act).
- **C.** The Ralph M. Brown Act. The Ralph M. Brown Act is a state law requiring open and public meetings and has been applied to neighborhood councils through the Act's definition of legislative bodies.
- D. Government Code § 1090. Government Code section 1090 is a state law that prohibits public officials and employees from having a personal financial interest in public contracts. Because Neighborhood Councils are given some limited authority to recommend or advise on City contracts and to make purchases using City funds, Government Code section 1090 is applicable.
- E. Federal Employment Practice Laws. In addition, Neighborhood Councils abide by laws and policies preventing workplace violence, sexual harassment, and discrimination.

#### City Laws Rules Governing the Neighborhood Council System

A. The Los Angeles City Charter. The City Charter created the Department of Neighborhood Empowerment, the Board of Neighborhood Commissioners,

and a citywide system of Neighborhood Councils. Article IX, sections 900 to 914 relate to the Neighborhood Council system.

- B. The Los Angeles Administrative Code. The Administrative Code consists of administrative and procedural City ordinances. Chapter 28. relates to the Neighborhood Council System. Other relevant sections include section 5.517 (administration of the Neighborhood Empowerment Fund), spaces), section 10.2.1(b) (funding for neighborhood purposes grants), section 20.36 (neighborhood council elections), and section 22.535 (neighborhood council office and meeting spaces).
- **C.** The Los Angeles Municipal Code. The Municipal Code contains criminal and regulatory ordinances. The City Council has passed ordinances within the Municipal Code, which relate to, among other things, notice to the Neighborhood Council system regarding certain land use matters. General City contracting rules can be found in the City Charter (starting at section 370) and within the Administrative Code (starting at section 10.1).
- D. City of Los Angeles Personnel Policies: The City recognizes that a workforce of individuals with diverse personal backgrounds, ideas, talents, and experiences facilitates an opportunity for each individual to make a unique contribution to the workplace and to provide superior and equitable service to all of the communities of Los Angeles. Harassment or discrimination based on a protected category as defined by the Fair Employment and Housing Act or (FEHA) activity that interferes with the City's goals of maintaining a diverse, equitable, inclusive, and productive workplace is not tolerated. The Office of the City Attorney Labor Relations Division may be asked to investigate questions in this area pertaining to Neighborhood Council boards or board members. When this occurs, board members are expected to comply with the investigation. Failure to do SO may give cause for removal of the reluctant board members board service by the Department.
- E. Fundraising Rules. The city's campaign finance ordinance restrictions do not apply to Neighborhood Council elections. However, any donations candidates receive are considered gifts which may require them to recuse themselves if the candidate is elected. Recusal will be requires on any matter which directly involves the donor or has the requisite impact on the donor if the donor has given gifts in the amount of \$500 or more in total during 12 months prior to the decision. If the Board candidate is a public official with disclosure obligations, such as a city employee, applicable gift limits of City and state law would apply to contributions received by the Board candidate.

#### **Board of Neighborhood Commissioners**

The Board of Neighborhood Commissioners establishes policies and promulgates rules and regulations relating to the Neighborhood Council System. Pursuant to section 902 of the City Charter, the Board is responsible for policy setting and policy oversight, including the approval of contracts and leases and the promulgation of rules and regulations for the Neighborhood Council System.

#### Neighborhood Council Policies

- A. Neighborhood Council Bylaws: The bylaws of a Neighborhood Council are established to provide a written framework and an organizational structure for the Neighborhood Council. Bylaws establish, among other things, an organization's management structure, procedures, and dispute resolution processes.
- **B. Neighborhood Council Standing Rules:** The Standing Rules detail the administrative rules of a neighborhood council. As a best practice, a copy of the Standing Rules should be added to the Neighborhood Council website making it accessible public.
- C. Parliamentary procedure Robert's Rules of Order or Rosenberg's Rules of Order: Parliamentary procedure is a tool to help neighborhood council boards to be more effective and productive during their meetings. A neighborhood council's bylaws state which rules of order apply.



- The Department may require newly elected board members to participate in a mandatory orientation prior to board service. All mandatory trainings must be completed before board service can begin.
- To learn more about candidates for Neighborhood Council board service, we may ask you to provide demographic information. The information is used by the Department to improve the direct neighborhood council services it provides Neighborhood Councils.

Judith Quiñones has been a founding member and participant of ABRA (Against Bigotry, Responding with Action) from June 19, 2020 to the present. We consider her to be a substantial and ongoing participant in our organization's activities. We are located at 10549 McClemont Ave., Tujunga, CA 91042. ABRA has maintained this address since its inception and is a not-for-profit, community service organization. ABRA meets at least monthly and commonly multiple times a week leading into our events. During the pandemic, meetings have been held online via Zoom.

ABRA has organized demonstrations in support of Black Lives Matter in Sunland-Tujunga, we gathered for Sunland-Tujunga's first LGBTQ+ Pride event, and we organized a local Juneteenth event that featured free food for the homeless and community members, catered by local restaurateurs of color. We have held educational online workshops, organized community clean-ups, and provided direct aid to local families in need. Most notably, we helped organize and co-sponsor our neighborhood's first Indigenous People's Day, which was attended by well over 400 people and for which we received special recognition from Senator Portantino.
