REQUEST:

- 1. Pursuant to Section 11.5.7 F 1(f) of the Municipal Code, a **Specific Plan Exception** to permit the location of a wireless telecommunication facility along a designated Scenic Highway within the Foothill Corridor Specific Plan (Ordinance No.170,694);
- 2. Pursuant to Section 11.5.7 F of the Municipal Code, an Exception from Section 8.B (2)(a) of the Foothill Corridor Specific Plan (Ordinance No.170,694) to allow a wireless telecommunication monopine structure, having a maximum height of 51 feet, in lieu of the maximum height limit of 33 feet permitted; and
- 3. Pursuant to Section 11.5.7 C of the Municipal Code, a **Project Permit Compliance** with the Foothill Corridor Specific Plan.

PROPOSED PROJECT:

Installation, use and maintenance of an unmanned wireless telecommunication monopine structure holding 12 panel antennae and one parabolic antenna, 51 feet high, and a seven foot high decorative masonry wall enclosure to screen four equipment cabinets, an emergency generator, and utility equipment to be installed on property containing a church facility.

## ENVIRONMENTAL CLEARANCE: ENV 2005-6504 MND

The hearing will be conducted by a Hearing Officer who will consider all the testimony presented at that time and any written communication received prior to or at the hearing, as well as the merits of the application as it relates to existing environmental and land use regulations. Written communications should include the above Case Number. The Hearing Officer will subsequently prepare a report, including a recommendation, which will be considered by the Planning Commission at a later date.

EXHAUSTION OF ADMINISTRATIVE REMEDIES - If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Planning Commission at, or prior to, the public hearing. Any written correspondence delivered to the Department before the Planning Commission's action on the matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
