### 5. PRESENTATION / SPEAKERS / Q&A:

- State Senator Caroline Menjivar Presented an Overview ('big picture focus') of what is being addressed in the City (e.g. bills, events, budgets, etc.). Holiday event in Van Nuys December 9<sup>th</sup>; STNC is welcome to attend.
  - Lydia Grant voiced concerns about density of building and evacuation ingress/egress
  - o Jon Von Gunten expressed concern over traffic/accidents in our area
  - Lallah Rowe discussed concern about water/sewage infrastructure that would challenge future growth.
  - Cindy Cleghorn thanked the Senator for improvement/maintenance efforts on freeways

# 6. Comments: LAPD, Elected Officials/Representatives, DONE, NC Budget Advocates, City Departments

- Sunland LAPD Senior Lead Godoy provided a status on crime in Sunland and Tujunga.
   Tujunga will have a replacement Senior Lead starting Nov. 16.
  - Lydia Grant comment to work more closely in the future on issues, including emergency evacuation.
- Diana Minor Diana Miner discussion on Oro Vista Recreational Impacts on Surrounding Neighborhood Public Safety Health not held; Ms. Miner not able to attend meeting.
- Michelle Vergara from Mayor's office provided a status on efforts to improving
  accessibility to 311, students have free transportation for the coming year in public
  transportation (e.g. BART), process to stay current with City events via text, City has Job
  fairs for filling jobs.
  - Lydia Grant questioned vacancies in the city which impact community needs if work/improvements not able to be done due to manpower.
- Declan Floyd, CA State Senator Anthony Portantino's Office Thank you for sponsoring Halloween event. Will be having annual holiday open house in December and will send out information when finalized, glad to have virtual meetings again.
  - Lydia Grant expressed gratitude for virtual meetings and noted that requirement for video cameras on was not part of original bill.
  - K Travers questioned Canyon Hills project. Declan noted that City is actively working on a solution noting overall community concerns.
- Christopher Khachadour, reported on bills signed by the Governor that
   Assemblymember Friedman initiated such as use of cameras for speeding, etc.
  - Nina Royal question about parking spaces with businesses and apartments which comes down to agreements between the business owners and the apartment owners.
  - Gerardo Barrientos questioned locations for cameras.
- Diana Oganesyan, Assistant Field Deputy for County Supervisor Kathryn Barger, General status and Officers holding a food distribution event, drive through event; flyer will be going out this week.
  - Cindy Cleghorn asked about how funding Section 8 payments are made -Through the City or through the County.
- City Council District 7 representative Ricardo Flores provided a status and updates on many projects going on at this time (e.g. construction on Foothill Blvd, cross-walk, ADA access, parking issues).
  - Pati Potter would like information on contacting neighbor next to Elk's Lodge to work with them and lessen their impact on the Elk's parking lot.
  - K Travers question about putting a camera at Ora Vista and Foothill; already targeted for a camera.
  - Lydia Grant— question about Winter Wonderland event, and update on pole banners. Ricardo has a list of banners and will update next month.
  - Cindy Cleghorn noted that speeding related signs are great but the one near Smart and Final is blocked by a tree.
  - Lallah Rowe questioned STNC participation in Christmas event as a guest or active participant. Alziri Camarena, DONE representation, asked that perhaps STNC have a table at event.

- Lydia Grant noted that we participated in Halloween event and appreciated being involved.
- Pat Kramer noted that the High Speed rail project may impact community air and water, expressed appreciation for speed sign at Ora Vista and Foothill and inquired about status of hiring another Officer for traffic speed enforcement.
- Lydia Grant noted that we host a Town Halls on traffic enforcement in January to update community on changes; Lallah Rowe stated that she could put it together with her Committee.
- K Travers noted that there is an event tab on website but invitations don't go out automatically; it is up to the organization to approach the Council Office. KT also thanked Ricardo for his active participation in our community.
- Aliziri Camrena, DONE representative, provided status of information on website and is working with NCs for in-person and virtual meetings.
  - Glenn Bailey commented on Youth Council and 411 protocols.

# 11. Motion to approve Community Impact Statement against CF 21-0002-S13 regarding Whiteman Airport Closure with a statement added to include a statement recommending use of available fuels less toxic to the community.

- Whiteman Airport Closure/Pacoima Community / November 12, 2020 Single-Engine Plane Crash / Public Safety / Air Pollution / Toxic Emissions.
- STNC Supports the Arleta Neighborhood Council statement: We write to you to oppose the closing of Whiteman Airport. Whiteman Airport is a vital part of the East Valley Community offering non-ubiquitous commercial, social and youth programs. The activities carried out at the Whiteman Airport are of critical importance for the commerce, safety, education and enrichment of the community and are unique to the Whiteman airport in the San Fernando Valley.
- The following include activities hosted as reported by the LA County Website:
   "COMMUNITY BENEFITS:
  - General Aviation Products, Services, and Facilities \* Business /Corporate Travel \* Aircraft Charter / Air Taxi \* Flight Training \* Personal Flying (Recreation and Training) \* Utility/Pipeline Patrol & Inspection \* Aerial Surveying & Observation \* Aircraft Storage \* Aviation Businesses (Aircraft Fueling, Maintenance/Repair, and Rental, Sale of Parts and Supplies, etc.) Emergency Preparedness & Response \* Aerial Fire Fighting Support (utilized by L.A. County Fire, U.S. Forest Service, and other support agencies) \* Law Enforcement/National Security \* Disaster Relief \* Search & Rescue (Civil Air Patrol—U.S. Air Force Auxiliary Squadron 35 is based at the airport) Community Services & Facilities \*

Aeromedical / Air Ambulance Flights \* News, Weather & Traffic Reporting \* Events (Annual Air Fair, Airport Tours, etc.) \* Youth Organizations / Educational Programs \* Aircraft Viewing Area and Meeting Facilities Destination & Special Events \* The airport directly supports approximately 246 jobs. Accounting for the multiplier effect, the airport creates roughly 412 jobs, with associated labor income of nearly \$19 million annually. Economic Impact \* The airport and the surrounding communities benefit from the estimated \$54.5 million in total airport-related (direct, indirect and induced) spending each year."

- Lionel Mares expressed a concern about pollution and desire to ensure they move to cleaner fuel.
- Nina Royal suggested that people that move into the area are aware of the airport before moving in.
- Lallah Rose reiterate that the airport is vital to our community.
- K Travers also commented about having a cleaner fuel.
- Lydia Grant commented that they are already planning to use cleaner fuels.
- Nina Royalrequested that the letter be changed to recommend include use of cleaner fuels.
  - An amendment (K Travers/\_\_\_\_\_) to include a statement recommending use
    of available fuels less toxic to the community.
