- Ofc Caloca provided an update on crime stats. The recent protests (deportation) at Verdugo High were uneventful, cleanups continue with Patrick. Cheryl shared a screen ad for a March 13th Tip-A-Cop event at Joselito's 11am-1:30pm with tips going to the Special Olympics.
- Sgt Ojeda encouraged attendance at the Tip-A-Cop event and discussed recent events. Ojeda said we are fortunate to now have Ofc Herrera, the Homeless SLO, dealing with homeless issues/RVs. Ojeda said that Officers may continue to be pulled away for other causes as has happened recently (fires, protests, etc.). Please be patient.
- Susan asked if we were going to have Tuesday's Coffee with a Cop event; Ofc Caloca said

it was on the schedule right now although one of the two officers might be pulled away for some other support.

- Jennifer Noyes, member of the community, said she went to the SunValley NC meeting and Ofc Herrera said that the best way to report homeless encampments is to send information to him at 813-400-7358 and/or email which is 38507@lapd.online. Ross said there is a direct link in the recent newsletter also. Deborah encouraged communicating with neighbors to encourage their involvement. Susan Denning, member of the community, said one of things she does when reporting a homeless problem (*e.g.* encampments) is to take the complaint number and text it to Ofcs Caloca and Hererra so they also know that 311 is getting the complaints.
- Jose Galdamez, Empowerment advocate, provided a status of updates including the Department's website has migrated to another website with links/information to the City domain. Galdamez noted that the NCs zoom licenses expire the end of April so if STNC wants a zoom license, they need to agendize it to receive the \$200 for the following year; the license is good from May 25 to end of April 2026. Updates are on the website as well as forms, information on elections, fliers, a template for board meeting minutes, guidance/guidelines, and more, making it available so NCs can find information quickly. Congress takes place during December in City Hall, and the regular Congress meetings are the first Saturdays of the month, via zoom at 1:30pm.

11. DISCUSSION/MOTION: STNC SELECTION OUTREACH.

• Cindy said she was almost through with the book and we are moving forward with Selection. Cindy showed the STNC website which has the first call for candidates. The Election day location first choice is the Council Office but we have not received a response to our inquiry so we are tentatively booking with the Elk's Lodge and waiting for their response, per Lydia. The election is February 12 and the month to sign up for office is March, per Cindy.

12. DISCUSSION/MOTION: To establish the STNC Emergency Preparedness Committee with Lydia Grant as chair. A motion was made by Carol and seconded by Cheryl.

- Cindy said that this Committee was discussed at the Executive Committee meeting and that STNC had such a committee some years ago. Lydia said she would start off as Chair to get it rolling but needs a co-chair and another Board member, and wants to involve the community. Lydia commented she does not was to repeat what happened during the recent fires where information was not being received by the community; Facebook and other resources were used instead. Lydia envisions a one-stop shop place on the STNC website where people can access information/links that include evacuation routes.
- Deborah commended the formation of the committee and having the community involved. Nina suggested that we contact members in the City of Los Angeles to involve them; Nina has information/contacts for City to include them as resources. Lydia said she has talked to other NCs about getting supplies and will also talk to the City. Susan said there are already emergency plans on-line and we need to coordinate with others. Lydia said she spent time during the recent fires getting information out to people via Facebook. Lydia hopes for a future presentation to the Board by Animal Services to address evacuation of animals. Jennifer Noyes said she has done emergency preparedness at the elementary school and can provide information given to the students which might be helpful; Lydia expressed an interest in getting the material. Lydia said we need to work with the district and that the last time there was an evacuation it did not go well.
- A vote was taken, forwarded by Carol and seconded by Cheryl, which passed.

The power of the people needs to be reasserted over government. Susan said the letter is good and asked if other NCs are doing a similar letter or if we planned to share the letter and get more ground support. Cindy said this was generated to assist other organizations (including other NCs) and her understanding is that other NCs plan to use it as an example as well as other community groups. We are making a recommendation to the City Council to take a stand on these issues as well.
- E. Discussion/Motion: To support CF 25-0065 regarding illegal fireworks enforcement and recommend video be used as evidence and fines raised so people submitting violations can receive half of the reward.
- F. Independent After Action Report. This motion instructs the Chief Legislative Analyst, in coordination with Los Angeles County, to procure an outside entity to prepare a comprehensive, independent After Action Report of the City and County emergency

- response to the January 2025 wildfires.
- G. Improving Communication Between Departments. The Council instructed the LAFD, in coordination with LADWP, to establish a formal protocol to provide the LAFD with weekly updates on the status of all water reservoirs and critical water infrastructure. This motion can be found here.
- H. Preparedness Plan for Mudslide Risks. The Council has instructed the Emergency Management Department, LAFD, and other relevant emergency response departments to report to the Council within 30 days on a comprehensive Emergency Preparedness Plan in preparation for mudslide risks. <u>Enhancing and Strengthening Los Angeles County's Emergency Preparedness and Evacuation Planning</u>

The events of January 2025, including unprecedented wildfires and significant flooding and landslides, laid bare the fact that Los Angeles faces unprecedented dangers from natural disasters. Along with the ever-present threat of earthquakes, the dangers of wildfire and flooding continue to worsen as a combination of climate change, overdevelopment in high fire danger severity zones (HFDSZ), misguided (in retrospect) forestry management policies, and other direct and indirect factors.

In recent years Sunland-Tujunga has endured multiple wildfires, including the 2017 Creek and 2018 La Tuna fires, as well as significant mud slides. During the January 2025 L.A. firestorms our community experienced at least two "near misses," with fires breaking out in the Tujunga Wash, and the Lidia Fire that ignited on the afternoon of January 8.

According to the 14th National Risk Assessment performed by First Street, 90% of Sunland-Tujunga is considered an area of severe or extreme risk for wildfire. Overall, 11,257 of 16,141 homes and 468 out of 548 businesses are at severe risk.

These dangers are further highlighted in a report issued by the Los Angeles County Department of Sustainability (CDS) in October 2021, "LA County Climate Vulnerability Assessment¹." This document lays out the current and future risks to all Angelenos. It includes some two dozen maps of specific areas and communities at risk for wildfire, inland flooding, coastal flooding, extreme heat, and other hazards that pose threats to life, property, and sustainability. Sunland-Tujunga has many such areas.

Reports like these, along with hard experience over the last decade and particularly recently, leave no doubt that the City and County have a long way to go before we can consider ourselves prepared for the next significant natural or human-made disaster. Neighborhood Councils, as the elected bodies closest to residents, can take a leading role in pushing for preparedness.

In our community, evacuations during the Creek and La Tuna bogged down into near gridlock in several places. Fortunately no human life was lost, though 40 horses perished when a rancher was unable to reach her property in time. Other communities have had frighteningly similar experiences. During the first hours of the Palisades Fire on January 7, 2025, hundreds of hundreds of people were forced to abandon their cars and flee on foot when evacuations came to a standstill. Likewise, during 2018's Woolsey Fire, the biggest in L.A. history, despite the best efforts of first responders some evacuations were chaotic, with much of the West Side slowing to a crawl as some 100,000 people fled south on PCH. The after-action report² described the dynamic nature of evacuations, including detours, necessitated by the fast-moving inferno. The authors noted in particular that "in the early hours, there was not a clear, single, comprehensive voice speaking to evacuation, and not all notification tools were used or used often enough." This kind of situation could easily play out in our part of the City.

We have gotten relatively lucky so far. However, if the City and County do not act decisively and quickly to update, upgrade, and modernize our emergency response systems and procedures it is only a matter of time before the next tragedy strikes. This is especially true when it comes to evacuations, where the City and County, like dozens of others throughout the state, is frighteningly unprepared. Public safety is the first obligation of public service. We have no time to waste.

Los Angeles is in Good Company

Over the last five years many California counties have taken deep looks at their emergency preparedness plans, particularly evacuation routes and procedures. The efforts include formal civil grand jury investigations, which have occurred in nearly half the state's counties, as well as expert third party analyses like the Woolsey after action report, academic studies, and news media investigations.

Collectively these efforts reveal the distressing degree to which communities throughout California are unprepared for mass evacuations. A recurring theme is significant and often potentially catastrophic shortcomings in evacuation planning and

infrastructure. Other issues include significant gaps in emergency alert systems and communications and poor coordination plans between and among different cities, counties, and agencies.

Here in Sunland-Tujunga it is essential that residents understand evacuation routes and constraints well in advance. We still have not fully evaluated evacuations in our community during the 2017 and 2018 fires or learned from them. It is therefore urgent that steps be taken to fill in those gaps in our knowledge. We must ensure our community is prepared for the next emergency before it happens. We still have time.

Motion

I THEREFORE MOVE that the Sunland Tujunga Neighborhood Council formally request that the 2025-2026 Los Angeles County Civil Grand Jury prepare an investigative report into the state of evacuation preparedness. The 2021-2022 Grand Jury final report included an investigation entitled, "Only We Can Prevent L.A. County Wildfires," which evaluated the status of the county's wildfire work farms. An evaluation of evacuation routes and constraints is a next logical step.

I FURTHER MOVE that the STNC form a standing Wildfire Working Group. The Group's first task will be to study evacuation routes, constraints, and procedures in Sunland Tujunga. The Group will interface with our local fire personnel and CalFire/Forestry Department personnel as appropriate. The Group will report back to the full STNC no later than October with findings and recommendations.

I FURTHER MOVE that the STNC invite representatives from the Los Angeles Fire Department (LAFD) to join a future meeting to discuss emergency preparedness, particularly evacuation planning.

I FURTHER MOVE that the STNC calendar follow-up meetings with LAFD regularly, and no less than once per quarter, to ensure we remain up to date on relevant information, which we will disseminate in the community.

ASSEMBLY BILL NO. 467

Introduced by Assembly Member Fong

February 06, 2025

An act to amend Section 54953.8 of the Government Code, relating to local government.

LEGISLATIVE COUNSEL'S DIGEST

AB 467, as introduced, Fong. Open meetings: teleconferences: neighborhood councils.

Existing law, the Ralph M. Brown Act, requires, with specified exceptions, that all meetings of a legislative body, as defined, of a local agency be open and public and that all persons be permitted to attend and participate. The act generally requires for teleconferencing that the legislative body of a local agency that elects to use teleconferencing post agendas at all teleconference locations, identify each teleconference location in the notice and agenda of the meeting or proceeding, and have each teleconference location be accessible to the public. Existing law also requires that, during the teleconference, at least a quorum of the members of the legislative body participate from locations within the boundaries of the territory over which the local agency exercises jurisdiction, except as specified.

Existing law, until January 1, 2026, authorizes specified neighborhood city councils to use alternate teleconferencing provisions related to notice, agenda, and public participation, as prescribed, if, among other requirements, the city council has adopted an authorizing resolution and $^2/_3$ of the neighborhood city council votes to use alternate teleconference provisions, as specified.

This bill would extend the authorization for specified neighborhood city councils to use the alternate teleconferencing provisions described above until January 1, 2031.

Existing constitutional provisions require that a statute that limits the right of access to the meetings of public bodies or the writings of public officials and agencies be adopted with findings demonstrating the interest protected by the limitation and the need for protecting that interest.

This bill would make legislative findings to that effect.

The California Constitution requires local agencies, for the purpose of ensuring public access to the meetings of public bodies and the writings of public officials and agencies, to comply with a statutory enactment that amends or enacts laws relating to public records or open meetings and contains findings demonstrating that the enactment furthers the constitutional requirements relating to this purpose.

This bill would make legislative findings to that effect.

Bill Text

THE PEOPLE OF THE STATE OF CALIFORNIA DO ENACT AS FOLLOWS:

SECTION 1. The Legislature finds and declares that neighborhood councils in the City of Los Angeles provide important community input to the city council. Unlike other legislative bodies that have access to regular meeting locations, these volunteer, uncompensated, elected members have had trouble finding public locations to hold their meetings. While the Legislature recently granted additional teleconferencing flexibility for legislative bodies, the additional teleconferencing flexibility of this act is necessary to account for the specific needs of neighborhood councils in the City of Los Angeles.

SEC. 2. Section 54953.8 of the Government Code is amended to read:

- **54953.8.** (a) (1) An eligible legislative body may use teleconferencing without complying with paragraph (3) of subdivision (b) of Section 54953 if the eligible legislative body complies with paragraphs (2) to (4), inclusive.
 - (2) An eligible legislative body may only use teleconferencing as described in this section after all the following have occurred:
 - (A) The city council for a city described in subdivision (c) considers whether to adopt a resolution to authorize eligible legislative bodies to use teleconferencing as described in paragraph (1) at an open and regular meeting.
 - (B) If the city council adopts a resolution described in subparagraph (A), an eligible legislative body may elect to use teleconferencing pursuant to this section if two-thirds of the eligible legislative body votes to do so. The eligible legislative body shall notify the city council if it elects to use teleconferencing pursuant to this section and its justification for doing so.
 - (C) Upon receiving notification from a legislative body as described in subparagraph (B), the city council may adopt a resolution to prohibit the eligible legislative body from using teleconferencing pursuant to this section.
 - (3) After completing the requirements in paragraph (2), an eligible legislative body that holds a meeting pursuant to this subdivision shall do all of the following:
 - (A) In each instance in which notice of the time of the teleconferenced meeting is otherwise given or the agenda for the meeting is otherwise posted, the eligible legislative body shall also give notice of the means by which members of the public may access the meeting and offer public comment. The agenda shall identify and include an opportunity for all persons to attend via a call-in option or an internet-based service option.
 - (B) In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.
 - (C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comment in real time.
 - (D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.
 - (E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed.
 - (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item

to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.

- (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.
- (F) At least a quorum of the members of the eligible legislative body shall participate from locations within the boundaries of the city in which the eligible legislative body is established.
- (G) At least once per year, at least a quorum of the members of the eligible legislative body shall participate in person from a singular physical location that is open to the public and within the boundaries of the eligible legislative body.
- (4) An eligible legislative body that holds a meeting pursuant to this subdivision shall do the following, as applicable:
 - (A) If the meeting is during regular business hours of the offices of the city council member that represents the area that includes the eligible legislative body, the eligible legislative body shall provide a publicly accessible physical location from which the public may attend or comment, which shall be the offices of the city council member who represents the area where the eligible legislative body is located, unless the eligible legislative body identifies an alternative location.
 - (B) If the meeting is outside regular business hours, the eligible legislative body shall make reasonable efforts to accommodate any member of the public that requests an accommodation to participate in the meeting. For the purposes of this subparagraph, "accommodation" means providing a publicly accessible physical location for the member of the public to participate from, providing access to technology necessary to participate in the meeting, or identifying locations or resources available that could provide the member of the public with an opportunity to participate in the meeting.
- (b) The legislative body shall comply with all other requirements of Section 54953.
- (c) As used in this section, "eligible legislative body" means a neighborhood council that is an advisory body with the purpose to promote more citizen participation in government and make government more responsive to local needs that is established pursuant to the charter of a city with a population of more than 3,000,000 people that is subject to this chapter.
- (d) This section shall remain in effect only until January 1, 2026, 2031, and as of that date is repealed.
- **SEC. 3.** The Legislature finds and declares that Section 2 of this act, which amends Section 54953.8 of the Government Code, imposes a limitation on the public's right of access to the meetings of public bodies or the writings of public officials and agencies within the meaning of Section 3 of Article I of the California Constitution. Pursuant to that constitutional provision, the Legislature makes the following findings to demonstrate the interest protected by this limitation and the need for protecting that interest:

During the COVID-19 pandemic, audio and video teleconference were widely used to conduct public meetings in lieu of physical location meetings, and those public meetings have been productive, increased public participation by all members of the public regardless of their location and ability to travel to physical meeting locations, increased the pool of people who are able to serve on these bodies, and protected the health and safety of civil servants and the public. Extending the operation of teleconference as conducted during the COVID-19 pandemic for neighborhood councils will continue these benefits.

SEC. 4. The Legislature finds and declares that Section 2 of this act, which amends Section 54953.8 of the Government Code, furthers, within the meaning of paragraph (7) of subdivision (b) of Section 3 of Article I of the California Constitution, the purposes of that constitutional section as it relates to the right of public access to the meetings of local public bodies or the writings of local public officials and local agencies. Pursuant to paragraph (7) of subdivision (b) of Section 3 of Article I of the California Constitution, the Legislature makes the following findings:

During the COVID-19 pandemic, audio and video teleconference were widely used to conduct public meetings in lieu of physical location meetings, and those public meetings have been productive, increased public participation by all members of the public regardless of their location and ability to travel to physical meeting locations, increased the pool of people who are able to serve on these bodies, and protected the health and safety of civil servants and the public. Extending the operation of teleconference as conducted during the COVID-19 pandemic for neighborhood councils will continue these benefits.

SEC. 5. The Legislature finds and declares that a special statute is necessary and that a general statute cannot be made applicable within the meaning of Section 16 of Article IV of the California Constitution because of the specific needs of neighborhood councils in the City of Los Angeles.

Conflict of Interest Announcement

Any Board Member who may have a conflict of interest and you have not consulted with the Office of the City Attorney, the Board should move to have the matter tabled until the next meeting so that the board member has an opportunity to consult with the City Attorney's Office. If the Board declines to table the matter, the Board Member may want to consider recusal before the matter is discussed. If choosing to recuse, the Board Member should state for the record, all reasons for the recusal and that they will be leaving the meeting during the discussion and voting. Because recusal may not always be sufficient, tabling of the matter at issue is always preferred to allow time for the Board Member to consult with the City Attorney's Office.

To reserve space at Rec and Parks Recreation and Senior Centers, please contact the appropriate Park Director to verify availability and complete the "Application for Use of Facility."

Neighborhood Councils may hold **meetings at no charge** during the center's operating hours. However, they will be responsible for their set-up and breakdown and will incur fees for facility use outside of operating hours. Please be aware that facility use is subject to availability. It is recommended that the "Application for Use of Facility" be submitted at least 30 days in advance of the desired date(s).

For special events, **all activities are subject to fees** unless organized in partnership with the recreation center. Special event requests must be submitted a minimum of 12 weeks before the event to allow for proper review and processing. Vendors providing services such as jumpers, food, performers, etc., must submit proof of insurance. Specific insurance requirements will be provided. Neighborhood Councils wishing to collaborate on an event should coordinate directly with the Director-In-Charge.

Zoom Updates

This is a friendly reminder to take action on renewing your Zoom licenses for the 2025-2026 year. The renewal period runs from April 1, 2025, through March 31, 2026.

To complete your renewal, please follow these steps:

- 1. **Board Approval**: Conduct a board action to approve the Zoom license renewal for the upcoming year, including the account and account holder.
- 2. **Notify Your NEA**: Ensure your Neighborhood Empowerment Advocate (NEA) is informed of the board's action.

NCs should have this completed by March 20, 2025. Once these steps are completed, the department will issue an invoice for the estimated amount of \$200.00 per Zoom account for the year. The approved amount will be deducted accordingly. We strongly recommend assessing your board's Zoom usage before making any decisions regarding license reductions, to avoid unnecessary costs. If you have any questions or need assistance, please feel free to reach out.

Website Updates

The department has made improvements to the website's front page, making it easier to share information related to neighborhood councils. A new Google Drive folder, named "Neighborhood Council Resources," has been created to facilitate document searches. This folder includes essential materials such as meeting minute templates, election outreach information, BONC policies, department guidelines, and resources for the liaison program. These updates enhance accessibility and streamline the process of finding important neighborhood council information.

How to Use the Google Drive Folder:

- 1. **Access the Folder** Click on the provided link to open the "Neighborhood Council Resources" folder in Google Drive.
- 2. **Browse or Search** Use the search bar at the top to find specific documents or browse through the available folders.
- 3. **Open and Download** Click on a document to preview it, or select the download option to save it to your device.
- 4. **Make a Copy** If needed, right-click on a file and select "Make a copy" to save it to your own Google Drive.
- 5. **Share Documents** Click the "Share" button on any file to send it to colleagues or stakeholders.

Community Impact Statement Portal

We'd like to remind you of the updates to the Community Impact Statement (CIS) Portal, as featured in our May 15th board newsletter. These updates aim to provide greater support and resources for Neighborhood Councils. The updated CIS Portal includes:

- Updated Board and Commission lists and contacts
- An option to include a City Planning Case Number when filing a CIS
- Updates to the auto-reply subject line to be more descriptive

SB 1174 Update

Senate Bill 1174, signed by Governor Newsom and effective January 1, prohibits local governments from requiring identification for voting or ballot submission, enforceable only if mandated by state or federal law. However, this law does not apply to the registration process. In Neighborhood

Council Elections, stakeholders are still required to provide documentation, including identification, for registration purposes. If your board would like more information, your board president can contact NCAD.

NC Election Update

<u>Election Administrators</u> continue to create Ballot Voting Models (BVMs) and review amended bylaws to ensure any updates are accurately reflected in the Neighborhood Council Portal and on the BVM. The BVMs contain information on board seats, the method of verifying stakeholders, and ballot information used to administer voting for NC elections. Our office will send BVMs to neighborhood councils for their review and confirmation that our office interpreted their voting requirements correctly. Neighborhood Councils can also add vacant seats with an unexpired term to their election at that time.

The Office of the City Clerk will host regional election information sessions for NC board members and NC stakeholders to learn about the 2025 All Vote-By-Mail NC Elections. The sessions will provide information on the election timeline, ballot voting models, candidate filing and voting processes, as well as our library and recreation center partnerships. All sessions will be held over Zoom. Election Administrators will email NC board members with dates and times for each region along with a registration form. You can also register here.
