Local Stakeholders can file **March 1, 2025 through March 31, 2025** to run for a seat on the Sunland-Tujunga Neighborhood Council. Voting will be Saturday, May 17, 2025, to fill the 21 Board seats. Here's what you need to know:

STAKEHOLDERS:

You are qualified as a Stakeholder in the Sunland-Tujunga Neighborhood Council if you live, work, own property in the City of Los Angeles within the STNC boundaries.

CANDIDATES:

If you wish to join the Council in shaping the future of our community, submit a Candidate Filing Form by 11:59 p.m. Monday, March 31, 2025.

VOTERS:

Stakeholders who are at least 16 years of age may vote from 12 noon to 4 p.m. on Saturday, May 17, 2025. Stakeholders will register in person on voting day, May 17, 2025.

REMINDER FOR 2025:

Stakeholders will need an official photo ID and may also need additional documentation to qualify in just one of the categories listed on the reverse side of this flyer.

At least one form of documentation must show a Sunland-Tujunga street address in the City of Los Angeles within the boundaries of the Sunland-Tujunga Neighborhood Council.

No P.O. Boxes are acceptable. No store receipts are acceptable.

All documentation must be valid as of January 1, 2025.

In addition to a valid photo ID, acceptable forms of documentation for Sunland-Tujunga Neighborhood Council candidates and voters include, but are not limited to:

STAKEHOLDER:

- All require a street address within the Sunland-Tujunga Neighborhood Council boundaries:
- Current CA Driver's License/Identification Card with Sunland-Tujunga street address (if a P.O. Box is listed, or if a valid Passport is shown, additional documentation must be provided from the appropriate list below).

RESIDENT:

- Mail with name and Sunland-Tujunga street address
- Current utility bill (gas, water, cable, etc.)
- L.A. County property tax bill
- Home mortgage statement
- Rental/lease agreement
- Homeowners association (HOA) bill/agreement
- Homeowner or rental insurance

BUSINESS:

- All require a street address in Sunland-Tujunga:
- Badge/identification card from employment in Sunland-Tujunga
- Letter from employer verifying employment in Sunland-Tujunga
- Personal business card
- Current business utility bill
- Mail showing business name and Sunland-Tujunga street address
- Commercial mortgage statement or receipt
- Commercial lease agreement or receipt
- City of Los Angeles business license
- L.A. County property tax bill

NON-PROFIT and Sunland-Tujunga COMMUNITY ORGANIZATIONS:

- PTSA membership for a school in Sunland-Tujunga
- Students at least 16 or older with ID from a Sunland-Tujunga school
- Letter from a Sunland-Tujunga school showing enrollment or volunteer participation
- Parent showing report card or school ID of child attending a school in Sunland-Tujunga
- Member of a Sunland-Tujunga community or religious organization with proof of membership (personalized letter, ID badge/card, membership roll/list, program with your name, etc.)
- Membership or ongoing participation in Sunland-Tujunga community organizations (for example, Rotary Club, Friends of the Sunland-Tujunga Library, Neighborhood Watch, Little Landers Historical Society, McGroarty Arts Center)
